Ossiform ApS ('us, 'we', or 'our') operates https://www.ossiform.com. This Privacy- and Cookies Policy describes how our organization collects, handles, and uses the personal data we collect from you when you use our website www.ossiform.com ('the Site').

When you visit our website, information about you is gathered to customize and improve our content. Below, we have described which information that is collected, its purpose, and which third parties that have access to it.

Personal data we collect

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact you or identify you. Our Company collects the following data:

- Personal information: If you send us an inquiry or sign up for any of our content or events via the forms on our website, we collect the personal identification information that you provide us (name, email address, phone number, country, and organization). We use cookies to collect data on how you use the Site to personalize content and ads, to provide social media features, and to analyze our traffic. We also share information about your use of our Site with our social media, advertising and analytics partners who may combine it with other information that you've provided to them or that they've collected from your use of their services.
- Log data: If you accept the cookies on our Site, we automatically collect certain information
 that your browser sends whenever you visit our Site (i.e. 'log data'). This log data may include
 information such as your device type, geographical location, referral channel, the pages of
 our Site that you visit, and the time and date of your visit.

How do we collect your data?

You directly provide Ossiform with most of the data we collect. We collect and process data when you:

- Register online or place an order for any of our products or services.
- Send an inquiry via any of the contact forms on the Site or by email.
- Sign up to our mailing list.



- Sign up to receive content from Ossiform.
- Sign up for any of or services
- When you accept the cookies on our Site.

How will we use your data?

Communications

Ossiform collects and processes your information in order to fulfill contracts we might have with you (e.g. if you place an order). In addition, we use your personal information to communicate to you to pursue our legitimate business interests. If you sign up to receive a newsletter or other content or services from Ossiform, we may contact you per e-mail with valuable content and special offers we think you might like and track how you engage with our content. You may unsubscribe from our communications at any time by clicking on the unsubscribe link at the bottom of the email.

Cookies

Like many sites, we use cookies to collect information. Out of these cookies, the cookies that are categorized as necessary are stored on your browser as they are essential for the working of basic functionalities of the website.

In addition, we use cookies that help us analyze and understand how you use this website, and marketing cookies to personalize content and ads and provide social media features. These cookies will only be stored in your browser with your consent. You also have the option to opt-out of these cookies. However, opting out of some of these cookies that are categorized as non-necessary may have an effect on your browsing experience. We use device information to improve and optimize our website (e.g. by generating analytics about how our customers browse and interact with the site, and to evaluate the success of our marketing and advertising campaigns).

We share your device information with third parties to help us use your data. For example, we use Google Analytics to help us understand how our visitors use the Site. This Site also uses a tool which collects your requests for pages and passes elements of them to search engines to assist them in indexing this site.

When you place an order through the Site, we will maintain your order information for our records unless and until you ask us to delete this information. We do not resell personal information and do not pass on your personal information to others. They are only registered with Ossiform ApS.

Your data protection rights

Ossiform would like to make sure that you are fully aware of all your data protection rights. Every user of the Site is entitled to the following:

- The right to access: You have the right to request Ossiform for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification: You have the right to request that Ossiform correct any information you believe is inaccurate. You also have the right to request Ossiform to complete information you believe is incomplete.
- The right to erasure: You have the right to request that Ossiform erase your personal data, under certain conditions.
- The right to restrict processing: You have the right to request that Ossiform restrict the processing of your personal data, under certain conditions.
- The right to object to processing: You have the right to object to Ossiform's processing of your personal data, under certain conditions.
- The right to data portability: You have the right to request that Ossiform transfer the data that we have collected to another organization, or directly to you, under certain conditions.
